CERTIFICATE OF ORGANIZATION

1 THIS IS TO CERTIFY, that at a meeting, duly noticed
2 called, and held for that Purpose, at the Cabin Creek School
3 House, in Musselshell County, Montana, on the Eighth day of
4 March, A.D., 1915, a Cemetery Association was organized, under
5 and by Virtue of the Laws of the State of Montana, and the
6 following proceedings were had, to-wit:

7 Upon Motion duly made, seconded and passed in said
8 meeting, T. E. Haurigan was chosen Chairman of the Meeting, and
9 upon a motion duly made, seconded and passed in said meeting,
10 E. B. Perry was chosen Secretary of said Meeting;

11 That thereupon, the object of the meeting having
12 been stated, and explained, the following members were pledged
13 to the organization of a Cemetery Association, to-wit:
14 Melchior Maart, Artemus R. Davis, Carl R. Weeks, Eugene B. Perry,
15 Walter Mohler, W. Clifford Colburn, Thomas E. Haurigan, Mrs.
16 E. B. Perry, Mrs. A. R. Davis, Mrs. M. Maart, Miss Edith Haurigan,
17 George Hartley, Mrs. C. R. Weeks, Mrs. W. C. Colburn;

18 That the name of said Cemetery Association was then
19 adopted by Vote of all members, and declared to be as follows:
20 "The Cabin Creek Cemetery Association".

21 That the number of persons fixed upon to manage the
22 affairs of the association was decided to be Six; and the follow-
23 ing members were chosen Trustees, and for the following terms:
24 Walter Mohler, and Mrs. E. B. Perry, for three year term; W.
25 Clifford Colburn, and Miss Edith Haurigan for Two year term; and
26 Carl V. Weeks, and George Hartley, for One year term; and said
27 election was had by ballot;

28 That the Second Saturday ^{of May} of each year was fixed upon
29 for the annual election of Officers of the Association; and the
30 manner of election was to be by Ballot;

31 That all the members above recited, as pledged, were
32 present, except George Hartley.
