**STATE OF MONTANA
RESTATEMENT OF ARTICLES OF INCORPORATION
NON-PROFIT CORPORATION**

Pursuant to the provisions of Section 35-2-226, et seq., Montana Code Annotated, the Chairperson and all the Trustees (Directors) of the below listed corporation amend its Articles and adopt the following Restated Articles of Incorporation, which amendment to the Articles does not require approval by the members nor by any other person other than the Board of Trustees:

FIRST: The name of the corporation is **Central Christian Church of Kalispell, Montana.**

SECOND: The corporation shall have perpetual existence unless sooner dissolved under law.

THIRD: This is a religious corporation. The purposes for which it is organized are the support of charitable, religious, benevolent, educational missionary undertakings, to own and control and maintain lands, buildings, structures and personal property necessary or incident to proper religious worship and teachings in accordance with the Holy Scripture and to receive by gift, donation, or otherwise monies and property, real and personal, for the uses of aforesaid, and generally to exercise all powers necessary or proper to be exercised in the context of said Church.

FOURTH: The number of Trustees of the corporation shall be three (3).

FIFTH: The corporation shall have members.

SIXTH: The name and address of the registered office/agent is:
