RESOLUTION No 9

A RESOLUTION FOR ADVANCEMENT OF THE TOWN OF SIDNEY,
RICHLAND COUNTY, MONTANA.

FROM AN INCORPORATED TOWN TO A INCORPORATED CITY OF A
THIRD CLASS.

WHEREAS, it manifestly appears to the Town Council of the
said Town of Sidney, Richland County, Montana, from the last Town
census of the said Town of Sidney, taken on or about the first day
of April, 1915, that the said Town of Sidney, Richland County,
Montana, now contains a population within its corporate limits
of upwards of One Thousand people, and

WHEREAS, by the laws of the State of Montana said Town
is entitled to be advanced from a incorporated Town to a incorporated
City of the third class.

NOW THEREFORE, be it Resolved by the Town Council of the
said Town of Sidney, Richland County, Montana:

Section 1, That the said Town of Sidney, Richland County,
Montana, be and the same is hereby advanced from a incorporated
Town to a incorporated City of a third class and the same shall,
from and after the passage of this resolution and the filing of the
same with the County Clerk & Recorder of Richland County, Montana,
be known and styled as "City of Sidney," and all ordinances, by-laws,
and resolutions and acts and proceedings of the said Town of Sidney
heretofore adopted and now in force, be and the same are hereby
adopted and declared to be the ordinances, by-laws, resolutions,
acts and proceedings of the "City of Sidney", as far as the same
are or may be consistent with the provisions of the laws of the
State of Montana relating to municipal corporations.

Section 2, It is further resolved, that a copy of this
resolution be filed and recorded in the office of the County Clerk
& Recorder of Richland County, Montana, wherein the said City of
Sidney is situated.

Section 3, It is further resolved that on and after the first Monday in May, A.D. 1915, all the officers of the said Town of Sidney, be and are hereby declared to assume their respective offices as the officers of the "City of Sidney."
